INTRODUCTION

The music program at Bilkent University provide breadth and depth of musical performance and academic experience. Music majors will work closely with a music faculty advisor on the requisite planning to pursue their goals. It is each student's responsibility to seek the assistance and counsel of their advisor.

Fundamentals of Musicianship (MSC 121 -122)

MSC 121 and 122 are non-credit courses designed for students who don't meet the required level of musicianship skills. Placement and exemption exams are given at the beginning of the semester. These courses are prerequisites for all history courses, so it is highly recommended that students finish these courses in their first year. The exempted students from MSC 121 and 122 may take Music History courses.

Theory I: Fundamentals (MSC 171)

MSC 171: Theory I, Fundamentals introduces students to the elements of music theory, including pitch and rhythm, triads and seventh chords, chord labeling, voice-leading principles, part-writing for triads in root position and inversion, harmonic progression, sequences, cadences, small formal units, and non-chord tones.

This course is intended for first-year entering students. However, if a student lacks some fundamental musicianship skills—such as sight-reading or basic solfège—it is strongly advised that they take MSC 171 after completing MSC 121 and 122. Following the test-out exam for MSC 121–122, students will be advised whether they would be better suited to take MSC 171 in their second year.

Lessons

Each student taking instrument lessons is assigned to a faculty member for private instruction.

Individual instruction is given in two-hour lessons. Students are entitled to 14 two-course hour lessons per semester. Five credits of instrument lessons are taken each semester for eight semesters. The instrument teacher selects the repertoire according to the guidelines. The instrument board must approve this program. Students cannot work on a piece that they have previously presented to an instrument or chamber music jury. Students are responsible for declaring if they have previously played any of the pieces before a jury.

Syllabus/Semester Program

Instrumental teachers must complete a syllabus in the first week of the semester and submit it to the Instrument Committee for approval.

Scheduling and Canceling Lessons

Students are expected to adhere to their scheduled hours for lessons and examinations. The Department of Music holds the student responsible for such appointments except in case of emergency or, if for good reason, the student cancels the lesson at least 24 hours in advance. The teacher is not obliged to make up for unexcused absences or lessons canceled for non-emergency reasons.

Teachers are obliged to give each student 14 two-hour lessons during the course of each semester. They are responsible for setting up a make-up class if they miss any of these meetings.

Grading

There are two midterm evaluations:

1. Week 7. Technical Assessment (except brass instruments - they fill out teacher assessment evaluation forms). %25 of the final grade.
2. Week 11. Teachers assess students' cooperation, commitment, preparedness, attentiveness, progress, and other indications of effort toward technical development and musical growth. %15 of the final grade. The dates of these assessments are posted at the beginning of each term.

Jury Examinations are held during the final examination period. The exact dates are announced at the beginning of the semester. Juries consist of 5 or 7 members. The majority of jury members come from student's field of study. Jury evaluation determines %60 of the final grade.

Passing the final exam is a mandatory requirement for successfully completing this course. Regardless of performance in the midterm exams, if a student receives a grade of "F" on the final exam, they will automatically fail the course.

Chamber Music Requirement

There are six compulsory Chamber Music courses: MSC 133, 134, 233, 234, 333, 334. Two additional chamber music courses MSC 433 and 434 can be taken as Restricted Electives. At the beginning of each term, the chamber music committee determines which ensembles students will participate in. The pieces to be studied are selected by the chamber music teachers and approved by the committee at the start of the term. One of the fundamental principles of the program is that the pieces must be studied in their entirety,

covering all movements. However, in exceptional circumstances, the committee may approve the study of only specific sections of a piece. Selecting a piece for the chamber music course that has already been studied in the instrument lessons is prohibited.

Structure and lessons

The Chamber Music Committee determines chamber music groups. Students are placed in Chamber Music groups according to the level of their instruments. Students and faculty may submit requests regarding to the type of ensemble they want to be in. Chamber music groups meet once a week for 2 hours.

Grading

Teacher's assessment of student's cooperation, commitment, preparedness, attentiveness, progress, and other indications of effort toward technical development and musical growth. %40 of the final grade. Chamber Jury Examinations are held during the final examination period in the concert hall. Ensembles should be prepared to present the full program. The exact dates are announced at the beginning of the semester. Jury evaluation determines %60 of the final grade. Regardless of performance in the midterm exams, if a student receives a grade of "F" on the final exam, they will automatically fail the course.

Orchestra and Choir Requirement

There are eight compulsory Orchestra/ courses: MSC 103, 104, 203, 204, 303, 304, 403 and 404. It is the main student orchestra, which meets from 10:40 to 12:30 every Tuesday and Thursday.

Piano and guitar students can take the choir courses regarding ensemble requirements: MSC 153, 154, 253, 254, 353, 354, 453, 454. Bilkent choir meets from 10:40 to 12:30 on Thursdays.

Concert Requirements

The primary goal of these recitals is to encourage students to perform regularly in front of an audience and to keep their repertoire fresh and ensure they are ready when a concert opportunity arises. These recitals serve as an excellent opportunity for students to prepare for the concert world by developing their repertoire and ensuring they are ready whenever a concert opportunity arises. Students should view these recitals as a chance to practice for a real concert experience, rather than merely treating them as practice for final juries. Fundamentals of Musicianship

MSC 121 and 122 are non-credit courses that are designed for students who don't meet the required level of ear training. Usually, in the entrance examinations, students may pass these courses, and they will be exempted.

Lessons

Each student taking composition lessons is assigned to a faculty member for private instruction. Individual instruction is given in two-hour lessons. Students are entitled to 14 lessons per semester.

Syllabus/Semester Program

Composition teachers must complete a syllabus in the first week of the semester and submit it to the Composition Committee for approval. The program on the syllabus will be the program the student must present in the final jury examination.

Grading

- 1- Teacher's assessment of student's cooperation, commitment, preparedness, attentiveness, progress, and other indications of effort toward technical development and musical growth. %30 of the final grade
- 2- Jury Examinations are held during the final examination period. Exact dates are announced in the beginning of the semester. Juries consist of 5 or 7 members. The majority of jury members come from student's field of study. Jury evaluation determines %60 of the final grade.

Passing the final exam is a mandatory requirement for successfully completing this course. Regardless of performance in the midterm exams, if a student receives a grade of "F" on the final exam, they will automatically fail the course.

Ear Training Requirements

After taking MSC 122, students must take at least two more Ear Training courses according to their level. If the students took MSC 121 and 122, they continue with the next level courses. Students who have studied Ear Training before can test out these courses. In this case, may take some other courses in lieu of ear training.

Department Seminars

Weekly composition seminars are part of composition lessons. They meet between 15:40 and 17:30 every Friday. Participation in seminars is mandatory for all composition students. Attendance and participation in seminars constitute %10 of the student's grade in the composition course.

Concert courses are also non-credit courses. If the student has registered for the course, they need to fill out the online Concert/Recital Program Notification Form. Failure to fill out the form on the indicated deadline may cause an U (unsatisfactory) grade.

Students need to have one of their pieces performed in a public concert. If no faculty members are able to attend, students can submit the program and the recording (if available) to the composition committee.

Fundamentals of Musicianship

MSC 121 and 122 are non-credit courses that are designed for students who don't meet the required level of musicianship skills. Placement and exemption exams are given in the beginning of the semester.

Lessons

Each student taking singing lessons is assigned to a member of the faculty for private instruction. Individual instruction is given in two-hour lessons. Students are entitled to 14 two-hour lessons per semester. 4 credits of singing lessons are taken each semester for eight semesters.

Syllabus/Semester Program

All teachers must fill out a syllabus in the first week of the semester and submit it to the Instrument Committee for approval.

Scheduling and Canceling Lessons

Students are expected to adhere to their scheduled hours for lessons and examinations. The Department of Music holds the student responsible for such appointments except in case of emergency or, if for a good reason, the student cancels the lesson at least 24 hours in advance. The teacher is not obliged to make up for unexcused absences or lessons canceled for non-emergency reasons.

Teachers are obliged to give each student 14 two-hour lessons during the course of each semester. If they miss any of these meetings, they are responsible to set up a make-up class.

Grading for Individual Instruction

There are two midterm evaluations in weeks 7 and 11.

Teacher's assessment of student's cooperation, commitment, preparedness, attentiveness, progress, and other indications of effort toward technical development and musical growth. %40 of the final grade. Jury evaluation determines %60 of the final grade.

Jury Examinations are held during the final examination period. The exact dates are announced at the beginning of the semester. Juries consist of 5 or 7 members. The majority of jury members come from student's field of study. Jury evaluation determines %60 of the final grade.

Passing the final exam is a mandatory requirement for successfully completing this course. Regardless of performance in the midterm exams, if a student receives a grade of "F" on the final exam, they will automatically fail the course.

Choir Requirement

There are eight compulsory Choir courses: MSC 153, 154, 253, 254, 353, 354, 453 and 454. The university choir meets from 15:30 to 17:20 every Thursday.

2. FINAL JURIES

Juries are held at the end of each semester. They function like final examinations for instrumental or composition lessons. Students must fill *Final Program Form* (Müzik Final Programı Bildirim Formu) by the given deadline. Students perform prepared pieces for faculty members and are graded on their performance. All students must perform a jury at the end of each semester. Any student who does not perform a jury without a valid medical report will receive a failing FX grade in lessons for that semester. The dates of juries coincide with final examinations. Instructors cannot excuse students from final examinations for any reason. Students are, therefore, requested not to ask for event permission during their scheduled final times. Juries consist of 5 or 7 members. The majority of these jury members will be from students' major area of study.

Passing the final exam is a mandatory requirement for successfully completing this course. Regardless of performance in the midterm exams, if a student receives a grade of "F" on the final exam, they will automatically fail the course.

During their graduation year, students do not perform a jury examination for "MSC 431 Instrument VII: Graduation Concert I". In this class, the final grade is determined entirely by the course instructor. Students take "MSC 432 Instrument VIII: Graduation Concert II" in their eighth and final semester. This course acts like a normal instrument course except the final jury consists of two concerts, a recital and a concerto, and they are open to the public. The final grade is determined by only jury evaluation.

Jury Grades

- A: Excellent - meets completely or exceeds all expectations
- A-: Very successful - meets all expectations; some deficiencies should be completed for the highest level
- B+: Very good - meets many expectations, some deficiencies should be completed
- B: Good - generally speaking in good level but should step up to overcome some deficiencies
- B-: Close to good level - there are some significant deficiencies
- C+: Above average - Level is sufficient but there are some significant deficiencies that should be overcome
- C: Average - Level may be sufficient but there are serious deficiencies
- C-: Below average - At the mediocre level. working tempo should be increased

D+: Attention! - There are critical deficiencies in many aspects

D: Attention! - At the lowest level of acceptable level

F: Unsuccessful

Fx: If you miss the final exam without a valid health report, you will receive an Fx

Fz: If you exceed the teacher's allowed absences during the semester, you will receive an Fz.

3. CONCERT REQUIREMENTS

Concert/Recital Course Guidelines

Overview:

- Concert courses are non-credit courses. Students enrolled in the course must complete the appropriate form by the deadline. These are pass/fail courses. Students may receive: P (Progress); S (Successful), and U (Unsuccessful)
- Students who take the MSC 100 Freshman Recital typically have 4 semesters to complete the requirement. If they register for the course but fail to give the recital, they will receive a "P" (Progress) grade and must fulfill the concert requirement in the fourth semester at the latest. Failure to do so will result in a "U" (Unsuccessful) grade.
- MSC 300 Junior Recital is normally taken in the fifth semester and must be completed by the sixth semester at the latest.

Recital Program Requirements:

- The recital program must be finalized by the end of the 4th week of the semester. Students should refer to the academic calendar for the exact date.
- Students are required to specify their recital programs and preferred dates through the form provided by the Music Department, which must be completed by the deadline.
- The recital must be at least 40 minutes in duration. Only one-fourth of the program can be selected from the student's current semester repertoire. The remaining works should be drawn from the student's broader repertoire, including pieces from previous semesters, but not those performed in past recitals.
- All program proposals are evaluated based on duration, content, and quality. Students may be asked to revise their programs accordingly.

Venue and Scheduling:

- Recitals are typically held at the Ahmet Adnan Saygun Hall or Studio 242 at 6:00 PM.
- Students are responsible for reserving the venue for their recital by contacting Sinem Özcan at the high school office.
- After the jury is determined, any cancellations or changes to the recital date must be processed through the appropriate form, with all necessary signatures obtained. Failure to follow this process will result in an automatic "U" (Unsuccessful) grade.

Program Content and Performance:

- The program may include pieces with piano accompaniment, solo sonatas, solo suites, and other solo pieces.
- All movements of sonatas must be performed, but selected movements can be played in suites. Concertos are not permitted in recitals.
- Etudes, caprices, pieces with piano accompaniment, and solo suites/sonatas for string instruments must be played from memory. For piano recitals, the entire program must be performed from memory.

Recital Cancellations and Changes:

- Any changes to the program must be submitted in writing to the relevant administrative assistant at least 10 days before the recital date, with the signed approval of the artistic department coordinator.
- If a recital is canceled without proper approval after the jury has been determined, the student will receive a "U" grade.

Grading:

- Grading in mandatory recital courses is conducted on a five-point scale. However, the end-of-semester grade will be recorded as either "Successful" or "Unsuccessful."
- The jury's evaluation will be separately communicated to the students.

Recital course for Composers

For composers, the recital course requires that at least one of their compositions be performed in public. This performance can take place in an on-campus or off-campus concert. Composers must submit the concert program to the Music Department Office. Additionally, they must complete the appropriate form by the 4th week of the semester.

4. ADVISING

4.1 Assignment of Faculty Advisors

Upon entering the Department of Music, each student is assigned a faculty advisor. Students are strongly encouraged to maintain regular contact with their faculty advisors regarding all academic matters, including degree program planning, petitions, advisement, and obtaining necessary signatures for academic actions, recitals, and final projects. Meeting with your advisor at least once per semester before course registration is highly advisable to ensure a well-organized and effective study plan. All formal registration requests (such as petitions, study outlines, terminal projects, and requests for leaves or extensions) must carry the signature of the student's advisor, regardless of whether the advisor approves the requested action. Students can find their assigned faculty advisor listed in the SRS system. Advisors are assigned by the Department Chair, who may provide supplementary advising when a student's primary advisor is unavailable.

4.2 Area of Study Coordinators (Sanat Dalı Koordinatörleri)

Each area of study is assigned a coordinator who oversees the study of each area. The students are encouraged to contact their coordinators if they have specific problems concerning their instrumental or compositional study.

PLEASE NOTE: Changing instrument teachers is not a simple matter and should not be requested without careful thought. This request is subject to the area committee's approval.

6. COURSE GUIDELINES AND SPECIAL PERMISSIONS

Class participation is an important part of the Music Department. You are expected to come to each class prepared and contribute to the class. There are no allowances for absences, and the department will not issue any exemptions or permissions for your absences.

6.1 General guidelines for attendance

In Bilkent University, each instructor are responsible to determine their attendance guidelines. These are always indicated in the syllabus. If you have questions about a course's attendance policy, please do not hesitate to ask.

Generally, students with more than three unexcused absences from studio lessons will automatically receive a failing "Fz" grade.

See Section 12: Code of Ethics for a comprehensive outline of professional conduct and expectations in the Department of Music.

6.2 Grades

The standard grading scale at Bilkent University ranges from A+ to F, with corresponding grade points (e.g., A = 4.00, B = 3.00, C = 2.00, etc.).

In addition to these, the following special grades are used:

- A+ — Awarded for exceptional performance. However, due to university-wide restrictions, A+ grades can only be given in courses with 25 or more enrolled students. Since most Music Department courses have smaller enrollments, the A+ grade is rarely applicable in our program.
- FZ — Given to students not eligible to take the final exam due to attendance or other requirements.
- FX — Given to students who do not meet the minimum course requirements and did not take the final exam.
- W — Indicates official withdrawal from a course. It does not affect GPA, but previous grades from repeat attempts may still be counted.
- I — Stands for Incomplete, given for valid, documented reasons (excluding illness). Students must complete all missing work within 14 days or before the next semester registration, whichever is sooner.
- T — Indicates Transfer credit from another institution. It appears on the transcript but does not affect GPA.
- S/U — Used in non-credit courses: Satisfactory / Unsatisfactory. These grades do not affect GPA.
- P — Indicates progress in a course that spans multiple semesters. It is temporary and does not count in GPA.

Grade Correction Policy

If a student suspects a clerical error in a grade, they must contact the instructor within 5 working days of the grade being posted. Confirmed errors must be reported by the instructor to the Faculty Dean's Office within 14 days or before course registration for the next semester. Grade changes after this deadline are not accepted.

6.3 Other Policies Concerning Courses

Course Repetition Policy

Students who fail a required course must retake it within the following two semesters. For first-year English courses, university regulations require immediate re-enrollment in the next available term. Registration for these may be done automatically by the university, and withdrawal from these courses may not be permitted. Students who fail the first English course may not take any other courses in the summer term. Those who fail the second English course may take other summer courses only if they also register for the failed English course concurrently.

Students on academic probation or with unsatisfactory status may choose to repeat any course in which they previously earned a C-, D+, or D.

Students in good academic standing may repeat a course from the past two semesters if they previously earned B-, C+, C, C-, D+, or D, provided space is available. Registration dates for repeated courses are announced by the university.

In the case of elective courses, if a student has already completed at least one course in the required elective group, they may take a different course from the same group as a replacement for a previously taken elective. In such cases, the original elective remains on the transcript but is excluded from GPA calculations. Once this substitution is made, it cannot be reversed. The original elective may still be reused to fulfill another curriculum requirement if applicable.

Students Who Exceed the Maximum Duration of Study

Students who reach the maximum duration of study (as defined in Article 3.4) and have taken all required courses at least once are granted make-up exam rights for courses they previously failed. If the failed course was an elective, the make-up exam may be taken in any other course within the same elective group.

For studio and lab courses with more than 30% practical content, students are not granted a written make-up exam; instead, they are allowed to participate in the practical components of the course as external participants.

Students must register for make-up exams or practical participation during the standard course registration period. Failure to register within this time is considered a waiver of exam rights for that semester. If a course is not offered that semester, students may retain their rights for a future term. Fees for make-up exams are determined based on credit hours and paid according to university policy. No excuse exams are granted for missed make-up exams.

Duration and Limits:

- Students with 6 or more failed courses: up to 2 semesters of make-up rights per course. If they reduce their failed courses to 5 or fewer, they are granted 3 additional semesters.
- Students with 5 or fewer failed courses: up to 4 semesters of make-up rights per course.
- If a student eventually has only 1 failed course remaining, they continue to retain make-up rights for that course.
- Students who exceed these limits without sufficient progress will be dismissed from the university.

Students who have no failed courses but a GPA below 2.00 at the end of the maximum study period may take make-up exams for any course in which they received a grade below C to improve their GPA.

Students who are granted unlimited exam rights but fail to take any exams for 6 semesters will lose their remaining exam rights.

Cheating and Plagiarism

If a student is suspected of cheating, attempting to cheat, plagiarism, or other similar violations during exams, assignments, reports, or any form of assessment, a disciplinary investigation will be initiated. While the investigation is ongoing, no grade will be given for the relevant work.

If the student is found not guilty, the exam or assignment will be graded, or a make-up exam or activity will be arranged. If the student is found guilty, they will receive a zero (0) for the relevant assessment, in addition to the disciplinary penalty imposed.

All graded activities that contribute to the final course grade — including projects, lab reports, assignments, and similar work — are treated as examinations in terms of disciplinary regulations.

6.4 Medical Reports, Make-ups

For reports issued elsewhere than Bilkent Health Center, you need to get your medical report approved at Bilkent Health Center. Students with a valid medical report who missed a Midterm or a Final due to illness are given a make-up exam. No make-ups can be given for exams missed if your report is late or has not been approved by Bilkent University Health Center.

6.5 Off-campus activity request (Üniversite dışı etkinlik izin formu)

If you attend an off-campus concert or similar activity, you need to fill out the appropriate form. However, this form does not grant you permission to be absent from the courses. It is important to check with your teacher and let them know your absence beforehand.

Similarly, if you attend an on-campus concert, you will not be exempt from the courses. You will still be considered absent. If you don't want to be penalized for absences, please plan accordingly and come to every class that you can.

7. PREPARATORY PROGRAM

7.1 Music courses during the English Preparatory Program

Students who are accepted into the undergraduate program but do not pass the English Proficiency Exam are enrolled in the English Preparatory Program. During this year, they are entitled to receive two hours of individual instrument or composition instruction per week. The purpose of these lessons is to help students maintain their musical form and prepare for the demands of the undergraduate curriculum. To continue receiving music lessons, students must maintain good standing in the English Preparatory Program. If a student fails the same English course twice, their right to receive instrument or composition lessons will be revoked.

Students enrolled in the English Preparatory Program are not required to take jury exams. However, they may request to play before a jury voluntarily in order to receive feedback. Regardless of participation, students do not receive grades for their musical studies during the preparatory year.

7.2 Music Preparatory Program

Music preparatory no longer exists as of Fall 2021. You will automatically start undergraduate education if you successfully complete the English Preparatory Program.

8. INTERNATIONAL EXCHANGE PROGRAMS

8.1 Erasmus+ Program (Europe)

Students in the Department of Music may apply to the Erasmus+ exchange program between their 3rd and 6th semesters. Applications are submitted once a year during the Fall semester of the previous academic year.

Eligibility Requirements:

- Minimum CGPA of 2.50
- Be enrolled in at least the 3rd semester and at most the 5th
- Applications must be submitted via: <https://erasmusbasvuru.ua.gov.tr>

Applications submitted outside this portal will not be considered. Application timelines are announced by the department. For details, please check with the Departmental Erasmus Coordinator and the Office of International Students and Exchange Programs.

8.2 Bilateral Exchange Agreements (Global)

In addition to Erasmus+, Bilkent also has bilateral exchange agreements with universities outside of Europe, such as those in the United States, Canada, and Asia.

Eligibility Requirements:

- Minimum CGPA of 3.00
- Must be in 3rd or 4th semester at the time of application

Application Materials:

- CV
- Statement of purpose
- Signed application form

- TOEFL score (required for U.S. and Canada destinations)

Qualified students must maintain the minimum CGPA requirement until departure. Students with disabilities are prioritized during selection.

Important Reminders

- Always follow deadlines announced by the department or the International Office.
- Contact your departmental coordinator early for guidance and available partner schools.
- Updated lists of available schools and deadlines are published annually.

9. GRADUATION

During the graduation year (Semesters VII and VIII), students work towards their final concert or project.

For instrument and voice students, graduation concerts are normally scheduled during finals week. If a student wishes to present their concert outside of that period, they must submit a formal petition to the department and provide a valid justification.

Concert dates and times are coordinated by the Music Office. Students are responsible for selecting their recital slot by signing up in person. Dates are reserved on a first-come, first-served basis. All graduation concerts are held after 17:00 and take place in the Bilkent Concert Hall. Failure to reserve a time may result in the Music Office assigning a date on the student's behalf.

The school is responsible for producing the concert flyer and printed program. Students must submit all required materials (including final repertoire and program notes) at least two weeks prior to the concert date.

Instrument Students

Instrument and voice students prepare a single, comprehensive program to be presented at the end of their eighth semester. During the MSC 431 Instrument VII course, they begin working toward this graduation recital under the guidance of their principal instructor. There is no jury examination in this course; students are evaluated solely by their instructor. In MSC 432 Instrument VIII: Graduation Concert, students perform their program before an official jury. The final grade for this course is determined entirely (100%) by the jury's evaluation of the graduation performance.

The final graduation concerts are always performed in their entirety. Cutting short or skipping a movement would result in a serious grade decrease.

Graduation Jury and Concerts

- The graduation jury consists of at least five faculty members, including at least one member from outside the student's department.

- All instrumental students are required to perform two separate concerts: one recital and one concerto performance.
- These concerts must be held publicly at the Bilkent Concert Hall.
- In both concerts, the full program prepared by the student must be performed in its entirety, without interruption.

Memorization Requirements

- Memorization rules are defined separately for each department or instrument group. Please check with your teacher and area coordinator.
- If a student performs a piece with sheet music that is required to be memorized, the jury may recommend a grade deduction. This deduction is applied after the final jury average has been calculated.

Voice Students

Voice students prepare a full recital program to be presented at the end of their eighth semester. During MSC 451 Voice VII, they begin preparing this recital under the supervision of their principal instructor. No jury is held in this course; students are assessed solely by their instructor. In MSC 452 Voice VIII: Graduation Concert, students perform their recital before an official jury. The final grade is based entirely (100%) on the jury's evaluation of this graduation performance. The recital must be at least 60 minutes in length, and the entire program must be performed from memory. Failure to meet these requirements may result in a significant deduction from the final grade.

Composition Students

Composition students in their final year work toward a single graduation project. In the seventh semester, they take MSC 411 Composition VII, during which they begin preparing their graduation portfolio under the supervision of their composition instructor. There is no jury examination for this course, and the final grade is determined solely by the instructor.

In the eighth semester, students take MSC 412 Composition VIII: Graduation Project, during which they present their final composition—typically a work for orchestra or large ensemble—before the Composition Jury. Alongside this, they are required to complete a graduation portfolio, which must be submitted to the department.

The portfolio must include:

- A current academic CV,
- A composition portfolio including at least seven works, with at least one written for orchestra or a large ensemble (normally completed as the graduation Project),
- Links to recordings of the submitted works,

- One academic paper written during the undergraduate program, revised and finalized based on instructor feedback.

The final grade for MSC 412 is calculated as follows:

- 30% Graduation Portfolio,
- 10% Presentation of the Portfolio,
- 60% Graduation Project (Orchestral Work) evaluated by the Composition Jury.

The jury evaluates both the graduation composition and the complete portfolio submission.

10. SCHOLARSHIPS

Bilkent University only awards merit scholarships that are based on academic achievement. The university does not give any need-based scholarships or other similar financial aids.

Merit Scholarship

Scholarship adjustments are made according to significant trends of students' academic achievement. The most important criterion is the students' instrument/composition grades given by the jury exams. However, their GPA and AGPA are also considered during evaluation. It is important to note that scholarships are not normally adjusted either way by sudden changes in students' grades. Long-term (biannual or annual) trends are taken into consideration. Students are expected to graduate at the end of their 8th semester. Failing to do so may also jeopardize their scholarship status.

The maximum duration for benefiting from talent-based scholarships and tuition discounts is 2 years in the English Preparatory Program and 5 years in the undergraduate program following preparatory education.

English Preparatory Program

Any scholarship loss due to failure in the English Program is reinstated once the students successfully complete the English preparatory program and start the undergraduate degree. This reinstatement is automatic. Students do not need to fill out any form.

Special Scholarship Conditions

To maintain scholarship eligibility, students must be enrolled in a minimum of 5 credit-bearing courses totaling at least 15 credits per semester. Students who fall below this requirement will have their scholarships suspended.

11. RULES REGARDING THE USE OF BUILDINGS, ROOMS AND PIANOS

11.1 Use of Faculty Building Study Rooms

Practice room rules

- Study rooms can be used until the building closes at 22:30.
- Each student will be assigned to a practice room at the beginning of the semester. You can use this room for the assigned times. You can access the programs with the QR code on the classroom door.
- Providing private lessons for a fee in instrument practice rooms is strictly prohibited. Violating this rule will result in disciplinary action.
- Instrument practice rooms are designated solely for musical practices. Their use for eating, drinking, resting, or similar purposes is strictly prohibited.
- The consumption of food and beverages is not allowed in the instrument rooms, and water bottles should never be placed on pianos.
- Users are responsible for the safety of their personal belongings while using the room. Instruments and personal items should not be left unattended in the rooms, and Bilkent University Faculty of Music and Performing Arts is not responsible for lost items.
- Rooms must be left clean after use.

Rehearsal Room Reservations (AASUS, Rooms 242, 215, 244)

It is possible to reserve rooms such as AASUS and rehearsal rooms 242, 215, and 244 for individual practice or group rehearsals. To do so, students must fill out the appropriate [Rehearsal Room Reservation Form](#).

Reservations are subject to availability and are processed on a first-come, first-served basis. Make sure to submit your request in advance and use the space responsibly.

Bilkent Concert Hall

The Bilkent Concert Hall is not available for student concerts or personal projects. However, students may request to use the hall for audio or video recordings, subject to availability.

In such cases, the following rules apply:

- Recording sessions may not exceed 3 hours.
- All recordings must take place during regular working hours (Monday to Friday, 09:00–17:00).
- Reservations are handled on a first-come, first-served basis and must be approved by the relevant administrative office.
- The hall must be used respectfully and left in proper condition after the session.

11.2 Piano Tuning

Pianos in the classrooms are tuned at the beginning of each term. If piano tuning is required for the classrooms or other problems in the room. Fill out the [Practice Room Report Form](#). There is no need to make a special request before concerts or exams. However, if the pianos still need tuning, the faculty secretariat can be contacted.

11.3 Library

The central library at Bilkent is open to all Bilkent members, allowing borrowing of books and other materials as well as access to other facilities. The library boasts an extensive sheet music collection and digital resources, making it a recommended resource for use during classes.

11.4 Audio and Video Recordings and Equipment

The school's audio and video recording equipment can be borrowed for 24 hours, with borrowing procedures managed by the dean's office.

12. CODE OF ETHICS

All students enrolled in the Department of Music are expected to adhere to the highest standards of personal, academic, and artistic integrity. As emerging artists, educators, and collaborators, your actions shape both your own development and the culture of our department.

Artistic Integrity

Music is both a personal and communal endeavor. We expect all students to show honesty, respect, and professionalism in their artistic work.

- **Original Work:** All performance, composition, and academic work submitted for evaluation must be your own.
- **Respect for Copyright:** The use of unauthorized photocopies of copyrighted sheet music or pirated materials is strictly forbidden.
- **Acknowledging Sources:** Any borrowed musical, textual, or conceptual material must be properly cited, whether in written work, program notes, or compositions.

Academic Honesty

As part of a university institution, the Department of Music strictly upholds all academic integrity rules.

- **No Plagiarism:** Submitting another person's written or musical work as your own — even partially — is considered a serious offense.
- **No Cheating:** Any form of cheating on exams, assignments, or juried evaluations is subject to university disciplinary action.
- **Use of AI Tools:** Use of AI tools (e.g., ChatGPT, or other generative applications) is permitted only when explicitly allowed in the course syllabus. If the policy is unclear, students must consult the instructor before using such tools. Any approved use must be clearly acknowledged in the submitted work, indicating the tool's name, version (if known), date of use, and purpose. Students are responsible for critically evaluating all AI outputs and ensuring the final work reflects their own analysis and creativity. Unauthorized or undisclosed use constitutes a violation of academic

integrity. For the full university policy, see [Bilkent University Generative Artificial Intelligence \(GenAI\) Guideline](#).

- **Ethical Collaboration:** Group work must follow the course guidelines. Students are individually responsible for understanding the limits of acceptable collaboration.

Professional Conduct and Responsibility

Your behavior — in lessons, rehearsals, classrooms, and public performances — reflects your professionalism and respect for the community.

- **Punctuality:** Students must arrive on time for all lessons, rehearsals, classes, and events.
- **Preparation:** Come to lessons and rehearsals well-prepared. Chronic lack of preparation may affect both grades and eligibility for public performances.
- **Respect for Others:** Interact respectfully with peers, faculty, and staff. Disruptive behavior, verbal aggression, or dismissiveness will not be tolerated.
- **Confidentiality:** Keep feedback from juries, instructors, and class evaluations confidential and respectful.
- **Classroom and Ensemble Settings:** In classes, chamber music, orchestra, choir, and other ensembles, maintain focus and contribute positively. Arrive with all necessary materials (instruments, music, pencils, scores, etc.) and be ready to begin on time. Parts for ensemble rehearsals must be fully prepared in advance. Unprofessional behavior that disrupts the group may lead to warnings, grade penalties, or suspension from activities.
- **Electronic Devices:** Mobile phones and other electronic devices must be switched off or set to silent before entering any class, rehearsal, or performance. Unauthorized use during these times is prohibited and may result in warnings or grade deductions. In exceptional cases, inform the instructor in advance.

Attendance and Communication

Consistent communication is part of professional discipline.

- **Excused Absences:** If you are ill or unable to attend a class, rehearsal, or individual lesson, it is your responsibility to inform the instructor at least 24 hours in advance.

Failing to communicate an absence is considered disrespectful and unprofessional. In a professional setting — including music education — respect for your instructor's time is fundamental.

- **Missed Lessons:** Unexcused absences will not be made up. Students who notify their instructor ahead of time may request a make-up lesson, subject to instructor availability.

- **Active Participation:** Students are expected to attend other student recitals, masterclasses, and departmental performances within their area unless they have a scheduling conflict.

For example: if you are a violin student, you are expected to attend recitals by other violinists, students, violin masterclasses, and academic events related to violin.

This not only fosters a supportive learning environment but also helps develop a deeper understanding of your discipline and builds a sense of artistic community.

General Faculty Rules

- **No Private Paid Lessons Within the School:** Students are strictly prohibited from offering or receiving paid music lessons within Bilkent University buildings. All formal instruction must take place through the school's official channels.
- **No Unauthorized Sales or Distribution:** Students are not allowed to sell or distribute books, sheet music, photocopies, or other materials for profit or without prior approval.

Violations and Consequences

Violating the Code of Ethics — including artistic dishonesty, plagiarism, or unethical conduct — may result in:

- Grade penalties
- Suspension from recitals or jury participation
- Disciplinary referral to the university's disciplinary board
- Loss of scholarship (if linked to misconduct or academic probation)
